

Ontario Quarter Horse Racing Industry Development Program Mare Breeding Incentive Application



- An Incentive of \$1,000 will be paid to owner/lessee of the mare at time of breeding, upon provision of proof (veterinary certificate) of mare being in foal 60 days or more post breeding.
- Owners must submit a 2025 Mare Breeding Incentive Application form for each mare.
- Eligible mare must have been enrolled in the QHRIDP previously, or have raced at Ajax Downs or another Quarter Horse racetrack.
- Payment will be made to the owner(s)/lessee(s) of record) of the mare at time of breeding. Should ownership of the mare change, it is the responsibility of the owner at time of breeding to provide proof of the mare being in foal.
- Both mare and owner must be enrolled in the QHRIDP in the current year. Mare must reside in Ontario for 270 days, including foaling date.
- Applications are due no later than 15 days after the last day of racing.
