

Ontario Quarter Horse Racing Industry Development Program Third-Start Bonus Application





- A bonus of \$1,000 will be paid to the owner and trainer of record following the third start at Ajax Downs in 2025 by a Quarter Horse that has never made a start in Ontario in a previous year. (Exception for 2-year olds – see Criteria Book)
- Owners and trainers must submit a 2025 Third-Start Bonus Application form for each eligible horse to Ontario Racing along with documented proof of the horse's three starts.
- Applications are due to Ontario Racing by Aug. 15, and one week after the end of racing.
