



Ontario Resident Mare Program MARE ENROLMENT FORM

2025 FOAL YEAR

To qualify as an ONTARIO RESIDENT MARE, the mare must be enrolled with the Standardbred Improvement Program for each foaling year, be resident in the Province of Ontario at time of enrolment and remain resident in Ontario for 180 consecutive days including the date of foaling. Complete details of the Program can be found in the SIP Criteria Book.

The annual fee is \$100 to enroll a mare as an ONTARIO RESIDENT MARE prior to her foaling date. The annual fee to enrol a mare after her foaling date is \$300, payable by September 1 of the foaling year. Definitive third-party proof of residency and foaling in Ontario will be required before the mare will be accepted into the Program after her foaling date.

The Program Administrator reserves the right to amend, cancel or alter the Program and/or make changes to the terms, conditions, and benefits of any nature and kind whatsoever and, the signatories of this form hereby agree to be bound by such changes.
