



APPLICATION FOR PAYMENTS TO HORSE OWNERS

Ontario Racing is reallocating a portion of existing purse funding paid by Ontario Lottery and Gaming Corporation ("OLG") under the Amended and Restated Funding Agreement for Live Horse Racing to horse people who do not have the opportunity to compete for purse winnings during the suspension of horse racing in Ontario in response to the COVID-19 pandemic effective April 3, 2021. These payments are intended to be used for the sole purpose of ensuring the health and welfare of racehorses are maintained during the cessation of live horse racing. In order to be eligible to receive payments from Ontario Racing, horse owners are required to have their Trainers complete and sign this application which must be submitted to Ontario Racing Management Inc. ("ORM"). Ontario Racing reserves the right to accept or reject any application in its sole discretion, and to impose additional conditions relating to payments made pursuant to this application. All decisions by Ontario Racing/Ontario Racing Management and associated partners are FINAL.

Deadline to submit application to Ontario Racing - Wednesday, June 2, 2021 (No Exceptions)

Please Note: *The Trainer completing this form is acting on behalf of the Owner for the horses in their care and represented below. Both the Trainer and Owner will be bound by the conditions of this application as evidenced by the Trainer signing and submitting this application to Ontario Racing/Ontario Racing Management and the Owner receiving any form of monetary assistance under this program.*

Eligibility Criteria and Conditions:

May Training Benefit Payment - \$1,000 per horse:

- Any horse stabled in Ontario with a charted line in Ontario in 2021 and is not currently racing or training/stabled outside of Ontario without returning to Ontario April 5, 2021 shall receive \$1,000 in relief funding. **No application required.**
- The following horses that are preparing to race and are currently stabled in Ontario for the month of May are eligible to apply for \$1,000 in equine benefit funding:
 - Unraced in 2021 3- & 4-year-olds
 - Any horse who started in Ontario between September 1 - December 23, 2020 that was stabled in Ontario at the time of the start and remained in Ontario until December 23, 2020

If the horses to be submitted for May are the same that were submitted for the April equine benefit payment, you do not need to submit an application for May to receive the May equine benefit payment.

All horses under both criteria must remain in Ontario for the month of May to receive funding and make their first start in Ontario once live racing resumes in Ontario. If a horse qualifies under both criteria, the horse is eligible for only a single \$1,000 payment.

Additional Criteria:

- All payments received must be used for the care and maintenance of standardbred horses.
- Once racing resumes in Ontario, horses who have received benefits under this program **MUST** make their first start at an Ontario Standardbred racetrack.
- Ontario Racing reserves the right to request additional information to ensure all criteria has been met. Those receiving benefits under the program could be subject to an audit by Ontario Racing. Failure to meet the criteria will result in all amounts being repaid to Ontario Racing.
- All decisions are at the discretion of Ontario Racing and are **ABSOLUTE** and **FINAL**.
- Horses are currently under the care of an AGCO licensed trainer at the time the application is submitted.
